TERMS AND CONDITIONS FOR EXHIBITORS AT EMIGRATION FAIR 2010

1. The show organizers (Fairway Events BV) must have received the registration form (including appendix) by 4 January 2010.
2. The order in which the registration forms are received will in principle determine the exhibitors.
3. The show organizers accept registrations on an unbiased basis, however the organizers reserve the right to reject exhibitors.
4. The show organizers allocate stand space and determine the position of the stands.
5. The show will take place from 10.00 a.m. to 6.00 p.m. on Saturday 13 February 2010 and 10.00 a.m. to 5.00 p.m. on Sunday 14 February 2010. Exhibitors must have their stands fully fitted out and manned by 9.30 a.m. on 13 February.
6. Exhibitors may erect their own stands from 8.00 a.m. to 10.00 p.m. on 12 February. Basic stands can be fitted out from 11.00 a.m. to 10.00 p.m. on 12 February - from 11.00 a.m.
7. The exhibition will be taken down from 5.30 p.m. on 14 February and between 9.00 a.m. and 3.00 p.m. on 15 February..
8. Exhibitors may not cause damage in any way to the floors, walls, ceiling etc. of the exhibition hall. This rule also applies to stand erection. Attaching wires to the ceiling or to parts of the structure of the building for the purposes of suspending stand components or signs is prohibited. Exceptions may be made, but only in consultation and with prior permission in writing. The cost of any damage caused to property, inventory etc. belonging to third parties will be recovered from the person or company that caused the damage.
9. A registration may not be amended or withdrawn unilaterally by an exhibitor. If an exhibitor wishes to cancel his or her registration, the request must be made in writing, sent by registered letter to the show organizers. The show organizers may accept a request to cancel on condition that the exhibitor concerned pays a cancellation fee. This fee amounts to 50% of the invoice amount after the exhibitor's participation has been confirmed by Fairway if notice of cancellation is sent by 4 January 2010 at the latest, and 100% of the invoice amount after the exhibitor's participation has been confirmed by Fairway if notice of cancellation is sent after 15 January 2010.
10. Stand rental and additional costs must be paid within 14 days of the invoice date.
11. If the invoice is dated after 20 January 2010, the stand rental due must be paid immediately by means of telephone bank transfer.
12. If an exhibitor fails to pay the sums he or she owes within the specified term, the show organizers are entitled to withdraw the registration and/or refuse to make stand space available without prejudice to the show organizers' claim for payment of these sums.
13. In cases as referred to in point 12, exhibitors are not entitled to claim a refund of sums already paid.
14. Each exhibitor is liable for and should take out adequate insurance against all loss or damage of any nature whatsoever and indemnifies Fairway against all claims that others could make against Fairway in connection with said exhibitor's actions or omissions. The organizers accept no liability for loss or damage.
15. By registering to take part in the show, exhibitors confirm that they are familiar with the terms and conditions for taking part in EMIGRATION FAIR 2010 and accept them.
16. The show organizers' decision is final in all cases not provided for in these terms and conditions or where these Terms and conditions are deemed to be unclear.
