## **EXTRACT FROM THE 'TERMS AND CONDITIONS'**

### **REGISTRATION OF STAND SPACE**

The participant declares by means of the registration form, completed and sent to the organisers, that he agrees to the conditions for participation at the Emigration Fair (hereafter to be referred to as event) included in the 'Terms and Conditions'. No rights to assignment of stand space can be derived from the application. In certain cases the organisers may reject an application, assign less stand space than applied for, choose to change already assigned stand space or withdraw already granted stand space altogether without the participant being able to make a claim for compensation for any sort of damage. All the details requested on the registration form must be completed. The organisers have the right to refuse or immediately remove goods and services that are not included on the registration form or are deemed unacceptable on the grounds of the "Terms and Conditions", without being liable to pay any damage compensation.

### **CANCELLATIONS**

The organisers retain at all times the right to change the date of the event or to even cancel the event in exceptional circumstances (force majeure), without the participant being able to make a claim for compensation for any sort of damage. An application may not be unilaterally withdrawn and/or altered. The organisers may allow a request for cancellation of the application on the condition that the participant involved pays cancellation compensation. This compensation amounts to at least:

- 50% of the services ordered: when the registration is cancelled after receipt of the confirmation of registration;
- 75% when cancelling less than 2 months before the first set-up day for the event;
- 100% when cancelling less than 1 month before the first set-up day of the event, and including the VAT owed.

A request for cancellation may only be made in writing and sent by registered post.

### **STAND HIRE AND PAYMENT CONDITIONS**

Payment of the expenses must be made within 21 days of the invoice date unless stipulated differently in the 'Terms and Conditions'. In all cases the payment owed must be received by the organisers at least 14 days before the first set-up day of the event. If the participant does not fulfil his financial obligations, the organisers are authorised to not assign stand space or to withdraw already assigned space or no longer make stand space available, without prejudicing the organisers' claim for full compensation of these amounts. The organisers are authorised to place the recovery of monies owed to them by the participant with their lawyers, taking into account that the legal and extrajudicial costs and the valid statutory interest calculated from the expiry date for the monies due will be charged to the participant.

### **LIABILITY**

Goods are left in the exhibition centre or its grounds at the risk and expense of the participant. The organisers are not responsible for insuring the goods. The organisers are not liable for damage of any nature to goods or persons resulting from or in relation to participation in the event. Neither are they liable for damage to third parties caused by the use of the stand by the participant or his personnel. The participant indemnifies the organisers from claims from third parties on this account. The participant is responsible for and is obliged to be insured against all damage to goods belonging to and/or persons working for or by order of the organisers and caused in any way by his involvement or negligence, or that of his personnel or his contributions.

The participant indemnifies the organisers from any claims others could make in this respect.

### **FINAL CLAUSE**

The organisers have the right to take one or more of the following measures against a participant who acts in breach of the stipulations in the 'Terms and Conditions' or who does not follow the instructions issued by or on behalf of the organisers, without proof of default and without legal intervention, and at the expense of the participant:

- to immediately refuse the person involved access to the event and/or the exhibition centre and its grounds;
- to close and/or clear his stand;
- to take possession of the exhibited goods and everything the participant has set-up or used; without the participant having any rights to claim a refund or compensation for damage.
